We take the protection and safety of your personal data seriously and are committed to maintaining its confidentiality, availability and integrity of information and data as part of our business process. We strive to ensure that personal data collected during visits to our website is processed by us strictly in accordance with applicable law.

Objective and Scope

This Data Privacy Statement provides transparency about any personal data that may be processed through this website (material scope) and the respective safeguards provided to website visitors that reside in the European Union (personal scope), in line with Art. 13 of the EU General Data Protection Regulation¹ (GDPR), as well as local law based on the EU ePrivacy Directive² and the Cookie Directive³.

Technical Administration

Security Checks

Requests from Government Authorities

Personal data is transferred to government organizations and authorities only to the extent required by applicable law. If a competent government organization or authority makes a request to Safety io for personal data, we will analyze whether such request is justified on a case-by-case basis.

Beta test offer

We also offer you the opportunity to sign up to be a beta tester of our Safety io products and services through our website. Data provided during registration will be used only for the purposes of contacting you for said beta test opportunities unless you have provided consent for other uses, such as receiving other advertising or information related to Safety io.

Job Application

When applying for a job opportunity with Safety io, applicants will typically provide us with personal information. Such information may include, for example, first name, surname, mailing and email addresses, telecommunications data, educational details, historical career information and related references. Personal data provided during the application process will be used only for the purposes of considering your application unless you have provided your

consent for other uses (e.g., permission to contact you or retain your personal data for similar career opportunities in the future).

Legal Basis for Processing

We will only process your personal data:

- if you have given your consent to the processing of your personal data for one or more specific purposes;
- if and to the extent the processing is necessary for the performance of a contract to which you are party or in order to take steps;
- at your specific request prior to entering into a contract;
- if and to the extent the processing is necessary for compliance with a legal obligation to which we are subject;
- if and to the extent the processing is necessary in order to protect your vital interests or of another natural person;
- if and to the extent the processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in us; or
- if and to the extent the processing is necessary for the safeguard or pursuit of legitimate interests pursued by us or by a third party except where such interests are outweighed by the interests or fundamental rights and freedoms of the data subject which requires protection of personal data, in particular where the data subject is a minor.

We only process traffic and other location data, itemised billing, and line identification data that is subject to and in compliance with the above-named conditions, which are based upon the GDPR and local law based on the ePrivacy Directive. We only process cookies subject to and in compliance with the above-named conditions based on the GDPR and with the local law based on the Cookie Directive.

Recipients and Third Country Data Transfer

Safety io's directors, officer, employees, agents, and representatives may have access to personal data on a need-to-know basis if they need to carry out legitimate tasks .

The website is hosted in the USA, which means that certain data that you provide may require cross-border transfer.. Such transfer will take place taking into account the applicability and scope of EU legal regulations.

Data Security

Safety io uses technical and organizational security measures to protect the data supplied by you and managed by us to ensure its confidentiality, availability and integrity. These security measures are protected against manipulation, loss, destruction, and access by third parties, and our website security is continually being improved in line with developing technology.

Right to information
